



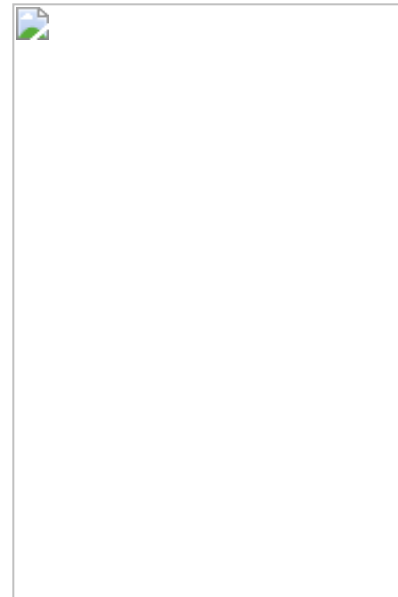
Greetings, CTE administrators:

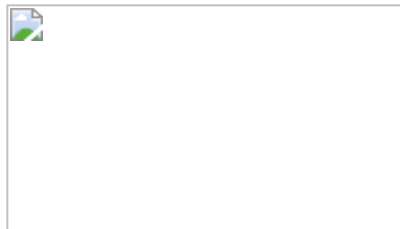

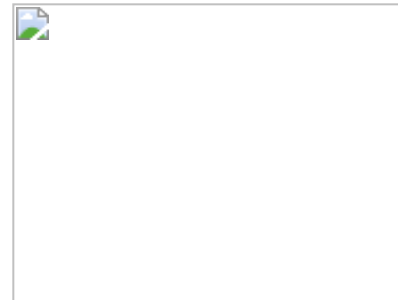
ACTE Admin Division Offers Webinar on Student Equity and Access

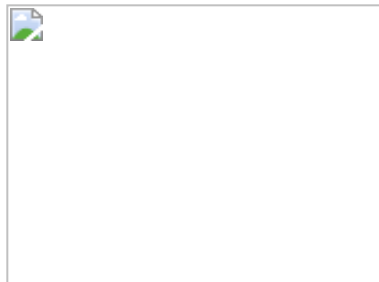

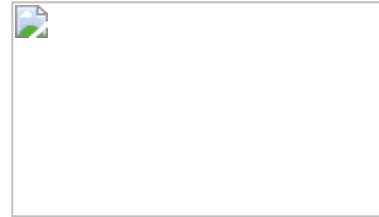

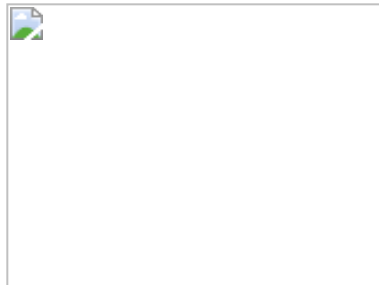
Deadline Extended for Student Trophy Design Contest

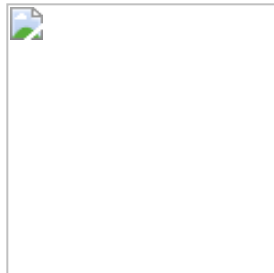
