Our attendance was not significantly higher. We are continuing to look at ways to draw more people.	If the Region I conference grows this will enhance engagement in ACTE as whole. There is also a benefit from any profit share generated by the conference.	The support that we received as been good. We worked through a few logistical issues while planning the 2024 conference but are in a much better place. It would still be nice to have a Region member portal like we have for our state.
